AGREEMENT OF CONTRACT

This Agreement is made and entered into as of 6 June 2022, by and between: **SSCOTA**, and **Sir Syed College**, Taliparamba.

WITNESSETH

WHEREAS, SSCOTA is committed to supporting educational institutions in their efforts to promote environmental sustainability and campus beautification; and

WHEREAS, College desires to implement green campus initiatives and campus beautification projects to create a more sustainable and aesthetically pleasing learning environment;

NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants contained herein, the parties agree as follows:

1. Financial Support

- 1.1 SSCOTA agrees to provide financial support to College in the amount of 25 Lakhs for the implementation of green campus initiatives and campus beautification projects.
- 1.2 The grant will be distributed to College in 3 installments, upon College's submission of a detailed budget outlining the proposed use of funds for each installment and SSCOTA's written approval.

2. Project Description

2.1 College agrees to utilize the Grant for the sole purpose of implementing the Project. The Project may include, but is not limited to:

• Green Campus Initiatives:

- Energy efficiency upgrades (e.g., lighting, appliances)
- Water conservation measures (e.g., low-flow fixtures, rainwater harvesting)
- Waste reduction and recycling programs
- Sustainable landscaping practices

• Campus Beautification Projects:

- Planting trees and shrubs
- Establishing gardens and flower beds
- Upgrading walkways and outdoor seating areas
- Minor building renovations for aesthetic improvements

2.2 College shall provide SSCOTA with a detailed Project plan outlining the specific initiatives and projects to be undertaken, a timeline for completion, and a budget breakdown for each component. SSCOTA reserves the right to approve or reject any proposed use of funds.

3. Reporting

- 3.1 College agrees to submit to SSCOTA quarterly reports detailing the progress made on the Project, including:
 - Expenditure of funds
 - Completion of planned initiatives and projects
 - Outcomes and impact of the Project (e.g., energy savings, water conservation, improved aesthetics)
- 3.2 College shall retain all receipts and invoices related to the Project for a period of three (3) years after the completion of the Project.

4. Acknowledgement

4.1 College agrees to acknowledge SSCOTA's support for the Project in all promotional materials and signage associated with the Project.

5. Term and Termination

- 5.1 This Agreement shall be effective from the date first written above and shall continue until the Grant has been fully expended and the Project has been completed.
- 5.2 This Agreement may be terminated by either party upon written notice to the other party for any material breach of this Agreement that is not cured within thirty (30) days of written notice.

6. Entire Agreement

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written.

7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Kerala.

8. Severability

If any provision of this Agreement is held to be invalid or unenforceable, such provision shall be struck and the remaining provisions shall remain in full force and effect.

9. Notices

All notices and other communications hereunder shall be in writing and shall be deemed to have been duly given when delivered in person, sent by certified or registered mail, postage prepaid, return receipt requested, or sent by overnight courier service, addressed as follows:

10. Counterparts

This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
