### Memorandum of Understanding

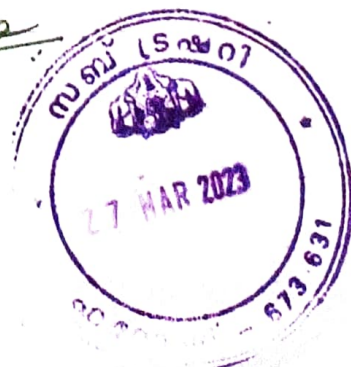

**Terms and Conditions:**

6. The parties shall bear their own costs associated with the implementation of the collaborative activities unless otherwise mutually agreed upon in writing.



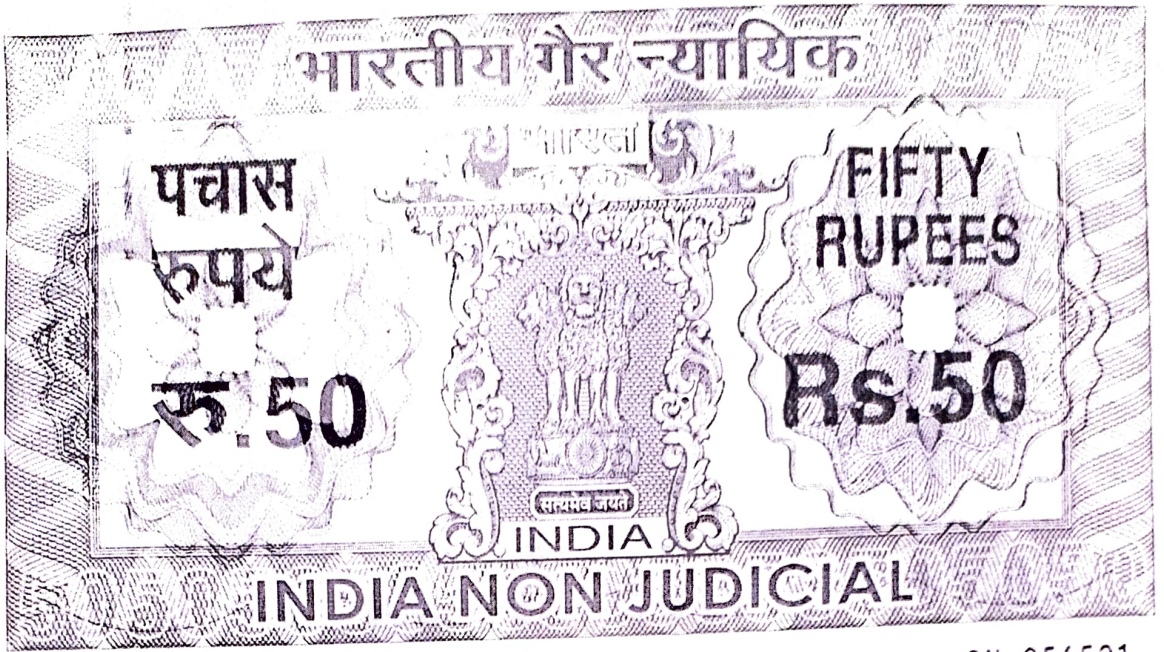

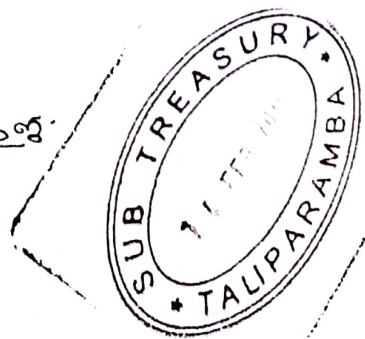

2. Dr Sheeja K P, Assistant Professor , Department of Malayalam, Nehru Arts and Science College , Kanhangad.





The expression party of the First Part and the Party of second part shall unless the context otherwise requires be deemed to mean and include their representatives, successors and assigns.

RUDSETI and PG Department of Commerce, Sir Syed College shall hereinafter also collectively be referred to as the "Parties" and individually as the "Party".

**Whereas**

1. RUDSETI is a non-profit organization with a sole objective of creating successful entrepreneurs thereby creating employment leading to economic and social development of Malabar.
2. PG Department of Commerce, Sir Syed College is affiliated to Kannur University.
3. RUDSETI and PG Department of Commerce Sir Syed College are desirous of entering into an agreement to work together in supporting student community to enter the field of entrepreneurship.

4. The parties appreciate each other's objective in promoting excellence, *inter alia*, in entrepreneurship in common areas of interest and are desirous of entering into an agreement for the aforesaid purpose. The Parties are also desirous of working together for identifying other areas of co-operation between them.
5. The parties hereto are fully desirous of recording the terms of their agreement into this agreement for the areas identified for co-operation and commit to co-operate.
6. The parties consider that this Agreement must be implemented diligently and in good faith, with due regard for each party's legitimate concerns

## **2. Objective**

The parties have agreed to work together with the prime objective of promoting and inculcating entrepreneurship culture among the students of PG Department in the college. Development of the soft skills of students is also a key objective.

## **3. Scope of the Agreement**

Based on the terms and conditions as may be mutually agreed upon between the parties from time to time, both the parties agree as follow.

## **4. Project Coordinator**

Both the Parties shall nominate a Project Coordinator each, as a single point of contact, on behalf of RUDSETI and PG Department of Commerce, Sir Syed College to coordinate the launch and successful implementation of the project.

## **5. Rights and Obligations of the Parties**

- 5.1.2 To Provide access to the programmes conducted by RUDSETI if required.
- 5.1.3 To conduct workshop for students.
- 5.1.4 To facilitate demo day for startups.

- 5.1.5 To conduct entrepreneurship aptitude test among students.
- 5.1.6 To start a Add on course on Entrepreneurship Development.
- 5.1.7 To conduct programmes to develop soft skills of the students.

**5.2 Rights and Obligations of Second Party**

- 5.2.1 To enroll Entrepreneurship development programs with RUDSETI
- 5.2.2 To conduct startup workshop with the support of RUDSETI
- 5.2.3 To promote academic entrepreneurship among students
- 5.2.4 To share and disseminate schemes and programmes through proper networks

**6. Amendment and Waiver**

This agreement may be amended, modified, superseded or cancelled, and any of the terms, covenants, representations, warranties, or condition hereof may be waived, only by a written instrument signed and executed by the respective duly authorized representative of each of the parties hereto. Further, any waiver of any of the terms hereof shall be valid if made by mutual consent of the parties.
