


1. Decided to frame out internal rules & regulations relating to Dept. Research Centre programs and activities - charge given to Dr. Siddique K.P.

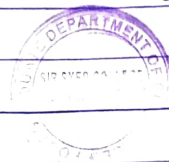
